Westall Secondary College is looking forward to another great year of teaching and learning and would like to advise you of the college's voluntary financial contributions for 2025.



Financial Support for Families

Westall Secondary College understands that some families may experience financial difficulty and offers a range of support options, including:

- **The Camps, Sports and Excursions Fund (CSEF)** – Families holding a valid means-tested concession card or temporary foster parents are eligible to apply. Each family receives \$225 per year paid for each eligible secondary school student. Payments are made directly to the school and are linked to the student. If you applied last year, you do not need to re-apply unless your circumstances have changed.

- **Payment plans**

For families who elect to pay the Voluntary contributions School Council is offering the following options for payment of the Charges and Contributions:

- Full amount at the beginning of Term 1, or
- Payment at the beginning of each Term (4 instalments), or
- Half-yearly payment: beginning of Terms 1 and 3 (2 instalments).

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
